



**Sprott Lithium Miners ETF (Nasdaq: LITP)** is the only<sup>^</sup> ETF to provide pure-play<sup>^^</sup> exposure to the lithium miners that supply a critical material for batteries, especially those that store clean energy and support the electric vehicle revolution. **LITP** seeks to provide investment results that, before fees and expenses, correspond generally to the total return performance of the Nasdaq Sprott Lithium Miners™ Index (NSLITP™). The Index is designed to track the performance of a selection of global securities in the lithium industry, including lithium producers, developers and explorers.

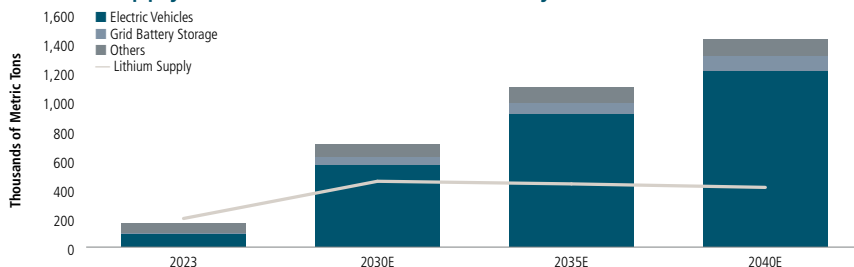

## Key Points

- Pure-Play Lithium ETF** – The only pure-play U.S.-listed ETF focused on lithium mining companies that are providing a critical material necessary to meet the rising global demand for batteries and energy storage.
- Growing Demand** – Electric vehicles are the largest consumers of lithium, and accordingly, clean energy demand for this critical mineral may increase 14 times by 2040, relative to 2023.<sup>†</sup> Lithium is also used in batteries across the spectrum of electronics and energy storage.
- Strategically Important** – Lithium miners, producers and explorers have received increased investments from Western governments and automakers that are securing onshore sources of materials to optimize the battery supply chain.
- Well-Positioned Companies** – Companies upstream in the supply chain may be well-positioned to benefit from the increased investment in lithium necessary to meet the rising global demand for energy and energy storage.

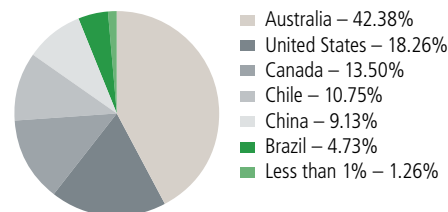
